

William Slater

The brother of Susannah Hargreaves, he had a great influence on the Hargreaves family. Thomas Hargreaves' father walked out when Thomas was four; Slater was employing Thomas aged 14 as a baker, and indeed Thomas was employed in Slater's businesses for the rest of his working life. William Slater seems to have had, in succession, a bakery and a butcher's business, but he was most successful in the manufacture of cotton goods, starting in Stoneyholme, Burnley, in partnership with a Mr Fulton, then moving to Spring Garden Shed in Plumbe Street and finally to Ashfield Mill in Caldervale Road.

Mahala also worked at Spring Garden Shed where she must have met Thomas, and they, and their children when teenagers Frank, Ernest, Harry and Clara, also worked in Ashfield Mill.

At the end of a very successful career William Slater retired to Heysham, to live in a very modest semi-detached house.

Death of Mr William Slater.

An Old Burnley Manufacturer.

Burnley people will regret to hear of the death of Mr. Wm. Slater which took place suddenly on Wednesday morning. The deceased gentleman had enjoyed good health up to his death which took place with tragic suddenness at his residence St John's-road Heysham. On Tuesday he was working in the garden, and on Wednesday morning he got up in his usual health and partook of breakfast. He then adjourned to another room to have a smoke, and expired immediately. Mr Slater was one of the best known cotton manufacturers in Burnley. He was born at Overtown, Cliviger⁵ some 77 years ago, and migrated to Burnley 55 years ago. At once he started in business as a butcher in Hammerton-street⁶ at the shop which was recently used as an office for the Central Skating Rink.⁷ Subsequently he removed to Sandygate⁸ and he erected two shops on the river arch at Bridge End.⁹ Mr Slater continued to carry on his butchering concern until about 37 or 38 years ago,¹⁰ when he started in business as a cotton manufacturer at Spring Garden Shed, Plumbe-street.¹¹ He at first ran 500 looms, and his venture proving highly successful, he bought the mill¹² run by the late Mr James Hitchen Whittaker, in Calder Vale. His firm grew to be a large one, and when he retired some three years ago and left it to his sons, the shed contained 900 looms.¹³

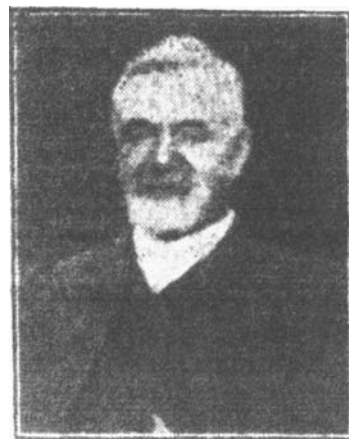

Mr Slater who was a Liberal in politics, was highly respected throughout the town. He left Burnley some three years ago, going to reside at Heysham. Though he had never taken an active part in politics, he once contested Burnley Wood Ward in the Liberal interests, and was defeated by the late Alderman Carrington. Since that time he had never made a further attempt in this direction. The deceased gentleman was at one time a well-known figure at Cronkshaws. At the New Year celebrations, Mr Slater, by request, generally sang Edwin Waugh's famous melody "A lift on the way". He was also connected with Enon Baptist Chapel. His remains will be interred today at three o'clock at the Wheatley Lane Inghamite Chapel graveyard.¹⁴ The coffin will arrive at Brierfield Station at 2-7 pm.

Death of Mr William Slater.

A large circle of friends will learn with regret of the tragically sudden death on Wednesday morning of Mr Wm Slater, of Greenfield House, Morecambe, formerly so well-known in Burnley as a cotton manufacturer. Mr Slater got up at the usual time on Wednesday, apparently at his wonted state of health. He was sitting in a chair awaiting breakfast when he suddenly expired from heart failure.¹⁵ He was a man of exceptionally vigorous constitution, and had not been attended by a doctor for over forty years. Mr Slater, who was 77 years of age, hailed from Cliviger. He started life in Burnley as a butcher, carrying on business for a long time in St James'-street.¹⁶ In 1871 – thirty-nine years ago – he started business as a cotton manufacturer in partnership with Mr Fulton at Stoneyholme.¹⁷ They afterwards moved to Cowburn's Shed in Plumbe-street.¹⁸ Twenty-two or twenty-three years ago¹⁹ the partnership was dissolved. Then Mr Slater took in his eldest son Frederick as a partner under the style of Wm. Slater & Son. Seventeen years ago²⁰ the firm moved to Ashfield Shed where the firm have since carried on business. Mr Wm. Slater retired from an active part in the business five years ago,²¹ and the concern was turned into a limited company under the style of Wm Slater & Sons Limited. Mr Slater who was a shrewd and successful businessman was the last survivor of a notable group of cotton men who used to journey to Manchester together.²² These were the late Richard Stuttard, William Briarley, Robert Emmott, Henry Nutter, John West and Cyrus Scaife. Mr Slater was always a sterling Liberal, but took no part in public life. He was a man of a most genial and sociable disposition, and was always a welcome figure in social circles. He was a familiar figure at Cronkshaw's room for many years, and at the annual New Year's Eve gatherings there his song "A lift on the way" was always one of the annuals that could not be spared. Mr Slater leaves seven grown up children by his first wife and one daughter of sixteen by the widow who also survives. The children by his first wife are Mr Frederick Slater, of Todmorden-road, Mr Joseph Slater, auctioneer, Mrs Joseph Heap²³ of Burnley, Mr P.S. Slater,²⁴ chemist, Mrs Riley,²⁵ Mr Benjamin Slater, Manchester-road,²⁶ and Miss Fanny Slater of Morecambe. While in Burnley Mr Slater attended Enon Baptist chapel.



The interment will take place this afternoon at the Inghamite chapel, Wheatley Lane. The coffin will arrive at Brierfield station about two o'clock.

William Slater's home addresses were, in 1861 4 Bridge End, Habergham Eaves; in 1881 and 1887 10 St James Street; in 1889 Wood Nook, 2 Brooklands Avenue Burnley; and around 1906 he retired to Greenfield Ho. St John's Rd. Heysham. He toured the world at some time, visiting William Hargreaves in Australia. He also went to New Zealand and brought back tree ferns and a piece of green jade. The jade was given to Mahala Hargreaves.
